

**CBDNA Athletic Band Committee**  
**CALL FOR MARCHING BAND PERFORMANCE VIDEO**  
**For presentation at the CBDNA National Conference**  
**March 26-29, 2025 – Fort Worth, TX**  
**Hosted by Texas Christian University**

**Purpose**

To provide a juried national performance opportunity for college and university marching bands. Selected video performances will be shown at one 50-minute session at the 2025 CBDNA National Conference, hosted by Texas Christian University in Fort Worth, TX.

**Guidelines**

- Submissions are due by Monday, January 27, 2025. We encourage you to submit as soon as possible to [cbdna.abc@gmail.com](mailto:cbdna.abc@gmail.com)
- Video from a single halftime performance between the dates of 8/01/23 to 1/20/25 (one show/entry per band)
- Time limit of 10 minutes
- Overhead view of show is preferred but multi-angle camera video is acceptable
- Please submit an internet link of your show along with the following information:
  - Information and description of the show
  - Internet link to the digital version of the video submission (YouTube, Vimeo, Dropbox, Box, etc.)

**Selection Process**

An undisclosed panel of jurors will be selected to review all video submissions. Similar to the process of ensemble selection for concert performances at CBDNA conferences, there are no strict parameters for the selection of marching band videos. Jurors will be instructed to make selections and rankings based on their own value system of excellence and/or achievement. The CBDNA Athletic Band Committee will then confer the jury selections and notify the submitters.

**Eligibility**

Bands are ineligible for selection in consecutive National Conferences. Selected bands from the 2023 National Conference will not be eligible for selection until the 2027 National Conference. Those selected for presentation at the 2025 National Conference will not be eligible for selection again until the 2029 National Conference.

**Responsibilities**

- Directors who submit must be paid members of CBDNA. Submissions by noncurrent CBDNA members will not be considered.
- Directors of selected videos will be notified by Monday, February 3, 2025
- Bands selected must have a representative at the National Conference to serve as a presenter. The director of the athletic band is the preferred presenter, but we realize that due to the nature of our respective seasons the notification of selection for presentation occurs approximately eight weeks before the conference. .
- The institution should already have all the applicable licenses (i.e. permissions to arrange) for the musical selections within the video submission.
- Each presenter will be given a brief two-three minute opportunity to describe and present the performance at a video session at the National Conference. The details of the presentation will be provided at a later date.
